Abandoned Vehicles

Due to numerous parking complaints the Borough is receiving regarding abandoned vehicles, the Carnegie Police are actively monitoring the Borough for violations. Any vehicle with an expired inspection and/or registration, including any vehicle that is inoperable due to flat tires or mechanical issues, will receive a towing notice posted on the vehicle stating you have 10 days to remove said vehicle from the Borough. The owner will be subject to the fines, towing and storage charges.

The Borough also has an ordinance prohibiting any type of trailers to be parked in the Borough parking spaces.

Residents 65 and Over

The Port Authority of Allegheny County recently began issuing a photo ID ConnectCard that will provide senior citizens with free transit. It takes the place of the commonly used Medicare card and existing bus pass that seniors have been using. These cards will no longer be accepted for free transit after January 1, 2020.

Community Safety

All units should have working smoke and carbon monoxide detectors on each floor. One of the carbon monoxide detectors should be near the furnace/mechanical room.

Please do not feed wildlife or stray animals in Pennsbury. This includes not having bird feeders on patios or decks. The only way to keep rodents and raccoons away is to eliminate the food sources. We must all do our part to keep our community pest free.

From the Office of the Tax Collector:

As a Homeowner you are responsible for all taxes and fees issued by the Tax Collector. Please make sure the Tax Office has your current mortgage company information or your personal mailing information if you pay your own taxes. **Failure to receive your tax and refuse bills is NOT an acceptable excuse for not paying your taxes and refuse fees on time.**

If you do not receive your tax or refuse bills by the following dates, please notify the Tax Collector, Patricia Notaro, at 412-276-6181.

Refuse Bills – Due date was January 31st. Any refuse bill still outstanding continues to incur a \$5 per month penalty plus a \$12.50 administrative fee.

Borough Taxes – The discount period ended on May 31 and payments were due at face value by July 31. Any payments made after July 31 will be assessed a penalty.

School Taxes – Will be mailed in August and due at discount by September 30. If you haven't received your tax bill by September 5th and pay your own taxes, call Patricia Notaro at 412-276-6181 for a duplicate bill.

Taxes NOT collected by Tax Collector:

County Taxes – handled through the County Tax office. Make sure the County has your current mailing information.(412-350-4600).

Wage Tax - All employed residents of Pennsbury Village must pay Wage Tax to Jordan Tax Service at 412-835-5243, #6.

Business Privilege Tax – This tax is due for anyone operating a business out of their residence and ALL landlords renting a unit. Contact Jordan Tax Service at 412-835-5243, #8.

Do not attempt to place any **electronic device (televisions, stereos, computers, computer accessories, etc.)** in any dumpster. This is illegal and you will be fined! Residents have access to a convenient service to properly dispose and recycle household hazardous waste – safely easily and responsibly. **These items include paints, household cleaners, compact fluorescent lamps (CFL), automotive products, garden chemicals, batteries and more.**

This service is in addition to your refuse pickup service provided by Waste Management and there is **no** additional cost to participate.
